ABSTRAK

Penelitian ini dilakukan di lima Desa yang berada Di Kecamatan Bandar Khalifah Kabupaten Serdang Bedagai, yaitu Desa Bandar Tengah, Desa Juhar, Desa Pekan Bandar Khalifah, Desa Gelam Sei Serimah, Desa Kayu Besar, sejak bulan juni 2023. Tujuan Penelitian ini adalah untuk mengkaji/mempelajari implementasi dana desa dan alokasi dana desa terhadap pembangunan desa. Penelitian ini juga bertujuan untuk mengetahui bagaimana upaya pemerintah desa dalam meningkatkan pembangunan desa melalui dana desa dan alokasi dana desa. Jenis data yang digunakan dalam penelitian ini yaitu data primer dan data skunder. teknik pengumpulan data dalam penelitian ini yaitu observasi, wawancara, dan dokumentasi. Hasil penelitian ini menunjukkan bahwa: (1) Pembangunan melalui dana desa terlaksana sesuai dengan kebutuhan setiap desa yang diputuskan pada saat musyawarah desa. (2) Alokasi dana desa dalam pembangunan desa belum terlaksana dengan baik dikarenakan alokasi dana desa tidak diperuntukan untuk pembangunan desa, dan lebih diutamakan untuk keperluan operasional perangkat desa (3) Pemerintah Desa dikecamatan Bandar Khalifah Kabupaten Serdang Bedagai bergantung pada dana desa dan alokasi dana desa dalam melaksanakan pembangunan desa, (4) Pemerintah Desa dikecamatan Bandar Khalifah Kabupaten Serdang Bedagai melakukan upaya peningkatan pembangunan desa melalui perencanaan *partisipatif* yang melibatkan masyarakat dalam proses pembangunan desa.

ABSTRACT

This research was conducted in five villages located in Bandar Khalifah Subdistrict, Serdang Bedagai Regency, namely Bandar Tengah Village, Juhar Village, Pekan Bandar Khalifah Village, Gelam Sei Serimah Village, and Kayu Besar Village, since June 2023. The objective of this research is to study the implementation of the Village Fund and the Village Fund Allocation in village development. The research also aims to understand how the village government efforts to enhance village development through the Village Fund and the Village Fund Allocation. The types of data used in this research are primary and secondary data. The data collection techniques used in this study include observation, interviews, and documentation. The results of the research indicate that: (1) Village development through the Village Fund is carried out according to the needs of each village as decided during village meetings. (2) The Village Fund Allocation for village development has not been well implemented, as it is primarily used for the operational needs of village officials rather than for village development. (3) The village governments in Bandar Khalifah Subdistrict, Serdang Bedagai Regency, rely heavily on the Village Fund and Village Fund Allocation for implementing village development. (4) The village governments in Bandar Khalifah Subdistrict, Serdang Bedagai Regency, are making efforts to enhance village development through participatory planning that involves the community in the development process.
