CHAPTER 1 INTRODUCTION

1.1 Backgroud

In the Book of Foreign Trade Statistics of the District or Riau City in 2020, Riau is currently one of the wealthiest provinces in Indonesia and its resources are dominated by natural resources mainly oil, natural gas, rubber, palm coconut and fiber plantations, based on Riau export value. The goods were exported through several ports spread across eight districts or cities in the province of Riau, one of which is Bengkalis district.

Bengkalis is one of the districts in the province of Riau, Indonesia. The area covers the eastern part of the island of Sumatera and Nusantara, with an area of 8,403,28 km2. The export target of Bengkalis district is only around Asia, the largest to China at US\$307.18 million, South Korea US\$42.41 million, India US\$19.43 million, Bangladesh US\$18.21 million, and Malaysia US\$70.4 million. The types of goods exported through the port of Bengkalis County include pulp, crude oil, and herbal materials worth US\$389.20 million, US\$5.79 million, and US\$3.58 million.

Matapors.com article (2021) about the Government of Bengkalis district supported three times the Movement of Export of Agricultural Commodities and Plantations stated that until June 13, 2021, based on the Full Automation of Indonesia Quarantine System, the export of commodities that went through Bengkaliz port amounted to 1,246,000 kg with the export value of Rp 12,255 billion and the frequency of Rp 12.255 million.

Therefore, the Government of Bengkalis district welcomes and strongly supports the Gratieks program, as it can be a strategic step and a long-term program in improving the outstanding commodity production side of the Bengkaliz district. In order to support export-import activities, entrepreneurs must understand the export-import procedures, export- import documents, both from customs, shipping and banking. Export-import procedures are the procedures that must be followed in compliance with the provisions of government regulations as well as the usage that applies in the execution of an export export transaction. The overall impact of this export-import trade, regardless of its causes, is to provide benefits to the countries that import and export. (Hutabarat,1:2002)

With the increase of the Importers and Exporters conducting international trade, from the Import sector, i.e. the collection of import customs duties and taxes in order to make the objective of receiving the State from year to year can be achieved as well as the export to the Customs exit but is dedicated to certain goods/commodities, the customs usually does not collect customs to support the domestic industry and specifically for the Export government will provide incentives such as the return of tax refunds on the goods exported.

These policies are given to business operators who are ordered to execute and administer in carrying out export-import transactions. For the forwarder, trader and executive who do not have sufficient knowledge of the export-import procedures of either customs, shipping, or banking.

Based on the problems above, the amount of export value obtained in Bengkalis export commodities, especially CV.Graha Mandiri, cannot be separated from the management of export flow activities that have been carried out.
