#### **CHAPTER I**

#### INTRODUCTION

### 1.1 Background of Study

The Bengkalis Regency Tourism Office should develop and promote tourism objects in Bengkalis city. It is possible to begin the implementation process by supplying information about the activity or location that user wish to promote. Website, brochures, tourism guidebooks, pamphlets, leaflets and regional social media account can all be used as reference sources.

Based on the information above, a guidebook is needed regarding an explanation of a tourist spot, especially historical tourism in Bengkalis city. There are several of historical tourism in Bengkalis city which will be written in two languages (bilingual), in English and Bahasa.

With this product, it is hoped that it can help visitors who want to visit historical tourism in Bengkalis city and they can easily get information on how and what is contained in historical tourism in the city. Foreign visitors or tourists will be increasingly helped by the information written in English and the local visitors or tourists will also get the same benefits with and explanations of the historical tourism to be addressed written in Bahasa.

In addition, based on pre-observation, there are no complete guidebooks written in two languages in Bengkalis. Therefore, the study is focussed on "The Making of an e-Guidebook of Historical Tourism Building and Object in Bengkalis city".

This study was focused in making e-guidebook of 9 historical tourism sites in Bengkalis City namely: Panglima Minal Tomb, Masjid Kuning, Dara Sembilan Tomb, Sang Naualuh Damanik Tomb, Dutch Water Tank, Huis Van Behauring Jail, Sultan Syarif Kasim Museum, Hock Ann Kiong Monastery, Masjid Istiqomah, and the product was provided bilingual.

# 1.4 Purpose of the Study

The purpose of the study was to make an e-guidebook of historical tourism sites in Bengkalis city.
