INTRODUCTION

1.1 Background of the Project

In this modern era, economic development is progressing rapidly. With the increasingly sophisticate technology from time to time. Now many people are starting to try by creating new businesses. Currently, business competition is getting bigger so that many business actors are developing their businesses creatively and innovatively.

One of the growth factors in Indonesia that contributes to economic development is small and medium enterprises. Small and medium enterprises really help the community in meeting their daily needs. In Indonesia, corn is the second staple food after rice. Specifically, corn is a food crop that is beneficial for human and animal life. One of the varieties of corn especially sweet corn is very popular with residents because it is delicious and sweet. Currently, sweet corn is quite popular with consumers as a mixture of foods such as pickles, cakes, and other. In addition to its sweet taste, corn has a fairly high nutritional content contained in 100 gram of sweet corn is 22,8 gram of carbohydrates; 3,5 gram of protein; and 1,0 gram fat (Hayati et al, 2022).

Potatoes are also a substitute for rice in Indonesia. Potatoes have useful content, the nutrients contained in potatoes include carbohydrates, minerals (iron, phosphorus, magnesium, sodium, calcium, and potassium), protein, and 9 vitamins, especially vitamins C and B1. Potatoes also contain fat in a relatively small amount, namely 1,0-1,5%. The content of amino acids in potatoes is also balanced therefore it is very good for health and can be used for various processed foods, both wet food and dry food (Hartiyah, 2022).

Carrots are perfectly healthy and nutritious vegetable. This vegetable has a high source of fiber and has natural fiber. Just a medium-sized carrot has 2 gram of fiber. Usually people who eat carrots avoid hypertension. Carrots also have vitamins and minerals that are important for the body. These include vitamin A, vitamin B, vitamin K, and vitamin B6. Corrots contain the most carbohydrates and vitamin A and carrots also contain a small amount of fat and protein (Kusuma et al, 2021).

Celery plant (*Apium graveolens L*.) is a nutritious plant that is widely used by the community, as well as a flavouring agent in food. Celery is efficacious to stimulate digestive and urinary enzymes (diuretic), relieve spasms (antispasmodic), lower blood uric acid levels, antirheumatic, diuretic, fart laxative (carminative), aphrodisiac, sedative, and antihypertensive. The high potassium content means that people who consume celery do not need additional potassium from the outside due to the diuretic effect of what the consume. However, celery is still rarely used by the public to facilitate the production of urine. The natural properties of celery are thought to have good solubility, in that can help in curing

urinary stones. Because one of the characteristic sufferer kidney stones is difficulty urinate (Herawati et al, 2020).

Corn and potato which is the staple food of the Indonesian people besides rice which can be processed into a variety of foods, both as semi-finished ingredients as well as finished ingredients. One of them is balls snack. Balls snack is a food made from corn and potatoes that have gone through a production process with a distinctive taste from the ingredients themselves. In this modern era, many business actors create ready-to-eat products that are reprocessed into products with various flavors, such as mozzarella cheese.

Business planning is still needed before carrying out the process of making balls snacks, even though there are only a few competitors who sell similar products. The purpose of this business plan is for the project to be sustainable, superior to other businesses and acceptable to consumers. In addition, price considerations are one of the benchmarks for consumers to buy balls snacks.
