CHAPTER I INTRODUCTION

1.1 Background of the Apprenticeship

The growing era of progress in science and technology has had a huge impact on human civilization, one of which is in the world of education from the lowest to the highest educational level. As Human Resources (HR) who have good values, they must be able to be independent, able to communicate well, have extensive knowledge, be able to make decisions and must be sensitive to the times.

With the increasing development of the times, it is increasingly difficult for human resources (HR) to find work because there is a lot of competition, especially for university graduates, the large number of graduates from various campuses who want to find work, while the available job opportunities are very limited. After graduation, of course, the diploma will be the main guide in finding a job. However, in reality, currently a diploma is not the main guideline for someone's acceptance to work either in companies or other agencies, but the main guideline at this time is a person's experience and skills at work, because academic grades cannot guarantee a person has experience and skills in work.

Therefore the campus requires students to take part in a job training program which is a form of implementation of lectures that are conducted directly to an agency or a company. The existence of job training activities is able to provide experience, hone the skills and abilities of students in the world of work. Every student is required to go directly into the world of work which is their respective field, so it is hoped that each student can immediately apply the knowledge they have learned before to the world of work.

Polytechnic is one of the campuses that requires all students to take part in practical work in order to complete their studies. Bengkalis State Polytechnic is a Diploma III and Applied Bachelor Education Institution established by the Bengkalis Regency government. The Department of Business Administration is one of the departments at the Bengkalis State Polytechnic. In 2016, this department opened a new study program, namely D4-International Business Administration and D4-Public Finance Accounting. This D4-International business Administration Study Program is engaged in the field of Economics and Business, where students learn about the business world, along with its scope. To prepare students to be ready to use in this field, the International Business Administration study program requires students to take part in practical work either in companies or other agencies for a minimum of 4 (four) months and a maximum of 6 (six) months.

CHAPTER II GENERAL DESCRIPTION OF THE COMPANY

2.1 Company History

PT. Pertamina is one of the the *Badan Usaha Milik Negara* (BUMN). BUMN is State Owned Enterprises e is an abbreviation of State Owned Enterprises engaged in the oil and gas sector. This company was founded on December 10, 1957 under the name PT Perusahaan Minyak Nasional, abbreviated as PT. PERMINA. This PT changed its status to become Permina State Company in 1960. 8 years later, on August 20, 1968, Permina State Company merged with Pertamina State Company to become the State Oil and Gas Mining Company (Pertamina). To strengthen this company, the Government issued Law no. 8 of 1971 which established Pertamina as a state-owned oil and gas company. Under this law, all oil companies wishing to do business in Indonesia are required to cooperate with Pertamina. On June 18, 2003, Based on Company Regulation No. 31 of 2003, the State Oil and Gas Mining Company changed its name to PT Pertamina (Persero) which carries out oil and gas business activities in the Upstream to Downstream Sector. Initially, Pertamina had a symbol in the form of a pair of seahorses flanking a yellow star. On December 10, 2005, Pertamina changed the symbol to an arrow forming the letter "P" with the basic colors green, blue and red which reflect dynamic elements and concern for the environment.

At the beginning of the operation of the refinery, the processing capacity only reached 25,000 barrels per day, in September 1975 the entire operation of the refinery shifted from reference to Pertamina. Since then the refinery has begun to make improvements in stages, so that its product and capacity can be increased again. At the end of 1977, the refinery capacity increased to 35,000 barrels per day, reaching 40,000 barrels in April 1980. Since then PT Pertamina RU II Sungai Pakning has been developing it in stages, and from 2002 to 2018 its production capacity has reached 50,000 barrels per day.

Since operating in 1971, the Putri Tujuh Dumai and Sungai Pakning oil refineries have made a real contribution to regional development and progress, especially the city of Dumai and its surroundings and have contributed greatly to meeting national fuel needs. Various products of fuel oil and non-fuel oil have been produced from the Dumai Seven Dumai - Sungai Pakning refinery and have been distributed to various parts of the country and abroad. The National Pride Refinery, so that the program to improve the quality of information and communication becomes important. PT Pertamina Internasional Refinery Unit (RU) II Production Sungai Pakning is a Refining and Process (R&P) unit, which is holding the International Refinery Refinery Unit II Production Sungai Pakning.

2.2 Vision and Mission

2.2.1 The vision of PT Kilang Pertamina International Refinery Unit (RU) II Production Sungai Pakning

2.2.2 Mission PT Kilang Pertamina International Refinery Unit (RU) II Production Sungai Pakning


The mission is the stages that must be passed to achieve the vision. In addition, the mission is also a description or purpose of why the company, organization or agency is in the midst of society. The mission of PT Kilang Pertamina International Refinery Unit (RU) II Production Sungai Pakning "To run a business in the oil and petrochemical processing sector that is managed professionally and with an environmental perspective based on Pertamina's values to provide added value to stakeholders".

2.3 Kind of Business

PT Kilang Pertamina International Refinery Unit (RU) II Production Sungai Pakning is a subsidiary of PT. Pertamina RUII Dumai. Sungai Pakning Refinery focuses on the crude oil processing business. PT Kilang Pertamina International Refinery Unit (RU) II Production Sungai Pakning Fuel Oil production refinery has the main task of processing crude oil into several types of Fuel Oil which is one of the suppliers of Fuel Oi`l to the Depot Siak for the needs of Riau Province, as well as Napta and LSWR products are exported and sent to RU II Dumai. In carrying out these basic tasks, PT Kilang Pertamina International Refinery Unit (RU) II Production Sungai Pakning has a commitment to grow and develop with the community. This commitment is reflected in the activities carried out by the company and agencies within the company.

2.4 Organization Structure

The organizational structure of the company can be interpreted as a multilevel line that contains the components that make up the company. The structure clearly describes the position, function, rights and obligations of each position within the scope of the company. Of course, this is intended so that every component in the company can function optimally and the company's wheels can always move effectively and efficiently. In addition, it also clearly describes the separation of work activities from one another and how the relationship between activities and functions is limited. In a good organizational structure, it must explain the authority relationship of who reports to whom, so there is one responsibility for what will be done. The organizational structure at PT Kilang Pertamina International Refinery Unit (RU) II Production Sungai Pakning is as follows:






Figure 2.3 Organizational Structure Source: PT Kilang Pertamina International Refinery Unit (RU) II Production Sungai Pakning

Each work position in the organizational structure of PT Kilang Pertamina International Refinery Unit (RU) II Production Sungai Pakning has duties and responsibilities to achieve the company'sgoals. The following is a job description of each organizational structure, namely:

1. Section HSE (Health, Safety, Environment)

The HSE Manager is tasked with and is responsible for creating safe working conditions and trying to avoid work accidents involving people, equipment, the environment as well as an advisor on environmental protection efforts.

a. Fire Insurance Section

The Fire Insurance Section has the duty and responsibility to create a reliable fire prevention system for refinery operations, through the procurement of hardware, software and Human Resources development, coordinating the implementation of HSE aspects and carrying out orderly general administration.

b. Safety Section

The Safety Section has the duties and responsibilities to create and review work procedures, identify and control hazards and carry out K3 audits, supervise the use of work safety equipment and provide explanations on prevention and prevention of accidents to all workers.

c. Environmental Section

The Environmental Section has the duty and responsibility to create a clean environment by seeking to reduce and monitor air, liquid and solid waste emissions that have a negative impact on the environment, implement the ISO:14001 EMS Environmental Management System, ensure that environmental protection equipment is maintained and operated properly. and create an environmentally sound corporate image.

d. Occupational Health Section

The Occupational Health Section has the duties and responsibilities to address health-related issues regarding diseases caused by occupational risks.

2. Section Maintenance

The maintenance manager is in charge and responsible for executing or repairing the company's operational equipment.

3. Section Procurement

Procurement within the company is in charge of and responsible for the supply activities, complaints of spare parts materials needed in the company's operations. This field is in charge of four sections, namely:

- a. Inventory Control Section
- b. Purchasing Section
- c. Service Warehousing Section
- d. Contract Office Section
- 4. Section Production

The production unit has the duties and responsibilities to ensure that the products produced are in accordance with the SOPs that have been set. This unit isdivided into 4 (four) parts, namely:

a. Utilities

This unit has duties and responsibilities to provide some of the needs of refinery utilities such as water, electricity, steam, compressed air and nitrogen.

b. CDU (Crude Distillation Unit)

CDU has the duty and responsibility to separate crude oil into several products through a physical separation process based on differences in boilingpoints by a process known as distillation.

c. IT&Y

This field functions to organize internal and external communications for therefinery so that the information needed is immediately obtained. This field is responsible for smooth communication to obtain information for workers within PT Kilang Pertamina International Refinery Unit (RU) II Production Sungai Pakning.

d. Laboratory

The main tasks of the Laboratory unit are quality control, quality insurance, feed intermediate products, feed finished products, production equipment and technical advice on maintenance and quality inspection of materials and spare part.

5. Reliability

The Reliability Manager is in charge and responsible for all matters relating to the reliability of the refinery in terms of maintenance (socialist). This field is in charge of two sections, namely plant reliability and equipment reliability.

6. Sr. Supervisor General Affairs (GA)

The duties of a General Affairs are quite complex and in their activities they must interact and coordinate both internally and externally with other departments or parties outside the company.

There are many tasks carried out by General Affairs including managing various permits required by the company, maintaining good relations with the environment around the company, being responsible for the existence and condition of company assets. General Affairs oversees three sections, namely:

a. Legal Section

The Legal Section has the responsibility for preparing completeness, drafting and checking the validity of all company legal documents according to the request of other relevant managers who require it, taking care of licensing issues for each company unit and ensure orderly administration related to the management of business operations in a complete, accurate, current and complete manner. b. Public Relation Section

Public relations within the company is very important. The task of public relations is to grow and develop good relations between institutions (companies) and the community, internally and externally in order to instill understanding, grow motivation and community participation in an effort to create public opinion that benefits the company.

Public Relations of PT. Pertamina is currently carrying out community development for the assisted groups assisted by several Community Development Officers (CDO).

c. Security Section

The Security Section is in charge of providing permits for guest visits to PT.Pertamina RU II Production Sungai Pakning. In the company there are 5 (five) security posts that are guarded according to a predetermined schedule.

2.5 The Working Process

The outher at the time of his internship was placed in the Public Relations department of PT. Pertamina RU II Production Sungai Pakning. Public Relations is an art of communicating with the public to build mutual understanding, avoid misunderstanding and misperceptions, as well as build a positive image of the institution. The duties and functions of the Public Relations Division of PT Kilang Pertamina International Refinery Unit (RU) II Production Sungai Pakning are as follows:

- Main Duties of the Public Relations Division.
 There are several main objectives of public relations, including the following:
 - a. Increase support, assistance, and participation from the public in the form of facilities, infrastructure, personnel, and funds, to facilitate the achievement of company goals.
 - b. Involving the public in solving various problems faced by the company.

- c. Creating and developing a good image for the company and also for the company and also for the leaders with the aim of establishing good relations between the internal public and the external public.
- d. Expanding the reach of connected customers to participate in the organizations quality improvement efforts.

2. Main Purpose of Public Relations.

In general, the main task of public relations is to promote understanding and knowledge of all the facts about the sequence of situations so that the company gains sympathy from these situations and events. The main tasks of public relations in a company or ganization are:

a. Creating an impression or image.

The impression a person gets of a person, product, or situation, according to that persons level of knowledge.

b. Knowledge and understanding.

Public Relations plays a very important role in providing information to the internal public and external public by providing accurate information and in an easy-to-understand format.

c. Creating Interest.

Public relations must also be able to create public interest in certain situations that have a major impact on the company/organization.

d. Admission.

Public Relations is responsible for providing an explanation to the public for situations or events so that the attitude of opposition, indifference that surround them can turn into understanding and acceptance.

e. Sympathy.

Printing is an activity of converting softcopy into hardcopy which requires a tool in the form of a printer. The method of printing documents is as follows:




Figure 3.1 Printing Documents




Figure 3.2 Scanning Documents Source : PT Kilang Pertamina International Refinery Unit (RU) II Production Sungai Pakning




Figure 3.4 Term Of Referee (TOR) "Screening Cegah Stunting" Source : PT Kilang Pertamina International Refinery Unit (RU) II Production Sungai Pakning




Figure 3.7. Documentation on National Occupational Safety and Health (K3) National Movement activities Source : PT Kilang Pertamina International Refinery Unit (RU) II Production Sungai Pakning

FILAGAM is Peat Water Filtration namely Reverse Osmosis (RO), and what will be developed are the Biofloc Tilapia Fish Business and Crystal Ice Business Among all these Job Descriptions, this is the final assignment of the project given by the job training mentor, namely Analyzing a Business of 3 businesses, the first of which is a business that has been running in 2022-present, namely the Reverse Omosis (RO) Business, and the Business to be developed, namely the Fish Business. Tilapia Biofloc, and Crystal Ice Business. The author analyzes the business using several formulas, namely: Production Costs, Maintenance Costs, Depreciation Costs, Revenue Costs, Profits, Break Event Points (BEP), Revenue Cost Ratio (R/C), and Payback Period (PP).
 - a. Reverse Osmosis (RO)

The Reverse Osmosis (RO) business is a business developed from Filagam is an abbreviation of Peat Water Filtration which was established on September 28 2022 until now. Judging from the sales of Reverse Osmosis (RO), this business has the potential to be developed. Based on sales in the last 1 year, income can be obtained which has increased, therefore the Reverse Osmosis (RO) business can be developed through sales targets and has increased every month, namely in September 2022 42 gallons, October 360 gallons, November 529 gallons, December 413 gallons, January 2023 565, February 2023 759 gallons, March 2023 862, April 2023 1,200 and May 1485. From Reverse Osmosis (RO) revenue which increases each month, a Reverse Osmosis (RO) business calculation can be obtained through a sales target of 55 gallons / day, 385 gallons / week, and 1,650 months. Based on the sales target, 60% of employee salaries can be calculated, namely Rp. 4,950,000, 28.12% Cost of Consumables Rp. 2,326,000, 6.6% for Uncontrollable Rp. 500,000 and 5.82% for cash, which is Rp. 500,000




Figure 3.11 Sales of Reverse Osmosis (RO) Source : PT Kilang Pertamina International Refinery Unit (RU) II Production Sungai Pakning




Figure 3.12 : Presentation Graphic of Cost Distribution Based on Sales Turnover Source : PT Kilang Pertamina International Refinery Unit (RU) II Production Sungai Pakning

Based on the graphic calculation above, it can be obtained that 100% percentage of sales turnover on RO can be explained on the total revenue

turnover of 1650 gallons/month, 60% of employee salaries of IDR 4,950,000, 24% of consumables of IDR. 1,980,000, 10% cash in the amount of Rp. 846,000, 6% money out of control.





Figure 3.13 : Presentation on Financial Management of Biofloc Tilapia D4 Source : PT Kilang Pertamina International Refinery Unit (RU) II Production Sungai Pakning




Figure 3.15 : Presentation on Financial Management of Crystal Ice Source : PT Kilang Pertamina International Refinery Unit (RU) II Production Sungai Pakning

3.5 Obstacle and Solution of Apprenticeship

3.5.1 Obstacles of Apprenticeship

Obstacles faced by the author during the job training process at PT Kilang Pertamina International Refinery Unit (RU) II Production Sungai Pakning:

- The difficulty in collecting all members to obtain questionnaire data on the Community Satisfaction Index for the CSR (Corporate Social Responsibility) Fostered Program mentored by mentors at the Arboretum Program is because many members are busy so it is difficult to contact them.
- 2. Lack of time in carrying out the tasks given by the mentor, one of which was working on 3 business analysis projects due to the large number of activities carried out outside the room so that at the time of the presentation, the task could not be completed optimally.

3.5.2 Solution of Apprenticeship

So, the solution to the obstacles faced by the author during the job training process at PT Kilang Pertamina International Refinery Unit (RU) II Production Sungai Pakning is as follows:

 By asking for agreement with the head and group members to go directly to their respective homes so that the data obtained can be complete and as desired. 2. After carrying out the presentation in the question and answer session the author was able to answer and explain in detail questions from the Public Relations (PR) and Community Development Officer (CDO) teams.

CHAPTER IV CONCLUSION AND SUGGESTION

4.1 Conclusion

After conducting job training at PT Kilang Pertamina Internasional Refinery Unit (RU) II Production Sungai Pakning, the following conclusions can be drawn:

- 1. There are several types of work during the internship, namely: Printing Documents, Scan Documents, Write Minutes, Responsible for designing an activity, Being in charge of documentation and videography on activities carried out by Public Relations (PR), Designing signposts for the land of the Fostered Corporate Social Responsibility CSR (Corporate Social Responsibility) group, Collect data on the Climate Village Program, Design flyers and stickers, Create a business analysis project for the Corporate Social Responsibility CSR (Corporate Social Responsibility) fostered program that is already running, namely Reverse Osmosis (RO), and what will be developed are the Biofloc Tilapia Fish Business and Crystal Ice Business
- 2. This job training program was carried out at PT Kilang Pertamina International Refinery Unit (RU) II Production Sungai Pakning for 4 months starting on 01 February 2023 – 31 May 2023. During the Job Training it was placed in Public Relations (PR) which was mentored by the Community Development Team Officers (CDOs)
- 3. The work system or activities carried out when conducting job training in the Public Relations (PR) section of PT Kilang Pertamina International Refinery Unit (RU) II Production Sungai Pakning is an online system using applications and manual systems. Work is carried out online such as sending email and applications that are often used are Canva to design brochures or banners, Zoom and Google Meetings to conduct online meetings. For the manual system, it takes the form of recording through a form using the existing format used for carrying out activities, meetings and presentations.

4. Obstacles faced by the author, lack of time in pursuing assignments from mentors, the solution is that the author uses sleep time to maximize project reports and when the presentation is finished in the question and answer session, the author can explain in detail questions from Public Relations (PR) and TIM Community Development Officers (CDO), obstacles Furthermore, it is difficult for the author to collect all members to get the Community Satisfaction Index questionnaire data. The solution is by asking for agreement with the chairman and group members to go directly to their respective homes. and the last obstacle is the lack of communication with the mentor so that the work instructions and assignments given are not clear.

4.2 Suggestion

After conducting job training at PT Kilang Pertamina International Refinery Unit (RU) II Production Sungai Pakning, there are several suggestions from the author as follows:

- 1. We recommend that the International Business Administration Study Program hold courses on design, so that international business administration students who are job training at PT Kilang Pertamina Internasional Refinery Unit (RU) II Production Sungai Pakning can provide the best design in completing the tasks given by the job mentor training
- 2. It is advisable for the Community Development Officers (CDO) TEAM at PT Kilang Pertamina Internasional Refinery Unit (RU) II Production Sungai Pakning to introduce apprentice students to all members of the CSR (Corporate Social Responsibility) fostered program and those who have become partners so that apprentice students are not awkward and make it easier for intern students to request the necessary data from the group.
